¹ Plans which do not completely use approved component manuals or approved products <u>must be submitted to DSPS</u> for review [no Individual Site Designs]

² POWTS receiving domestic wastewater only. Plans for systems receiving domestic wastewater combined with industrial wastes <u>must be submitted to DSPS</u> for review [and may also require DNR approval].

³ Plans for holding tank/grease interceptor combinations <u>must be submitted to DSPS</u> for review.

⁴ Plans for systems receiving high strength wastes <u>must be submitted to DSPS</u> for review.

⁵ Marathon County's plan review fees are the same as those charged by DSPS [see excerpts from Table SPS 302.65 below]. Plan review fee is not included in the sanitary permit fee.
